2009 EXHIBITION SEASON CALL FOR ARTISTS NEW DEADLINE: 9/10/2008

ROY G BIV Gallery for Emerging Artists is currently looking for artists for their 2009 Exhibition Schedule. A panel of three jurors including Dennis Harrington (Director of the Weston Gallery, Cincinnati, Ohio), Mark Harris (Artist and Director of the School of Art, University of Cincinnati) and a juror who is to be named will select the artists. The selected artists will be grouped with one to three other artists. Group exhibitions may be submitted with a show concept proposal for the space.

ROY G BIV Gallery is a non-profit art gallery located at 997 North High Street in Columbus, Ohio's historic Short North District. ROY has been dedicated to supporting emerging artists since 1989, featuring thousands of artists during its seventeen years of existence. We pride ourselves on bringing new and exciting art monthly to the Short North.

The deadline for submission is September 10, 2008. Work submitted should not be dated older than 2006.

ENTRY PROCEDURE

For consideration, the artist must submit a ten to twelve image slideshow digitally on CD and in PowerPoint format only. Each PowerPoint slide is to be labeled with the following: number, name of artist, title of work, date of work, and dimensions. PowerPoint presentations should have a black or gray background and should not include sound except for video works. In addition to the PowerPoint presentation, the artist must include jpg files, that are 1MB or larger in size, of each image submitted.

Video artists can submit a selection of no more than 3 videos on DVD. DVD submissions should not exceed a playing time of 10 minutes per video.

An image/video list must accompany each submission, as well as, an artist's statement and resume.

No other supplemental materials will be taken into consideration during the jury process.

CDs and DVDs will only be returned if accompanied by a self-addressed stamped envelope.

CDs and DVDs of selected artists will be retained for use in the promotion of the 2009 Exhibition Season.

Incomplete applications will not be considered.

ENTRY FEE

There is a \$30 entry fee for non-members. The entry fee is waived for Artist level and above members of ROY G BIV Gallery.
