A panel of three jurors: Catharina Manchanda (Senior Curator of Exhibitions, Wexner Center for the Arts, Columbus, Ohio), Jennifer Bedford (former Senior Editor of the Bibliography of the History of Art at the Getty Research Institute), and Mary Jo Bole (Professor of Art at The Ohio State University) will select the artists. The selected artists will be grouped with one to three other artists. Group exhibitions may be submitted with a show concept proposal for the space.

ROY G BIV Gallery is a non-profit art gallery located at 997 North High Street in Columbus, Ohio's historic Short North District. ROY has been dedicated to supporting emerging artists since 1989, featuring thousands of artists during its twenty years of existence. All submissions must be received by: September 5th, 2009. Work submitted should not be dated older than 2006.

ENTRY PROCEDURE

For consideration, the artist must submit a **ten to twelve image slideshow** digitally on CD and in **PowerPoint** format only (**.ppt, not .ppx**) . Each PowerPoint slide is to be labeled with the following: number, name of artist, title of work, date of work, and dimensions. PowerPoint presentations should have a black or gray background and should not include sound except for video works.

In addition to the PowerPoint presentation, the artist must include **jpg files**, that are 1MB or larger in size, of each image submitted.

Video artists can submit a selection of no more than 3 videos. Videos must be submitted on DVD or CD as Quicktime (.mov) files with 740 X 480 aspect ratio for widescreen or 640 X 480 for fullscreen. The **first two minutes** of each video will be reviewed. DVD submissions should not exceed a playing time of 10 minutes per video.

Submissions must include an **artist statement**, an **image/video list** (number, title, date of work, and dimensions) and a **resume** on CD.

No other supplemental materials will be taken into consideration during the jury process.

Artists who have exhibited with ROY G BIV in the past three years (2007-2009) cannot apply. Artists who have participated **only** in the exhibitions: Pulp Art, Small Works, and ImageOHIO, may apply.

CDs and DVDs will only be returned if accompanied by a self-addressed stamped envelope.

CDs and DVDs of selected artists will be retained for use in the promotion of the 2010 Exhibition Season.

Incomplete applications will not be considered.

ENTRY FEE

There is a \$30 entry fee for non-members. Entry fee is waived for Artist level and above members of ROY G BIV Gallery.
